Dear Mr. Crawley-Gibson:

The National Archives and Records Administration (NARA) has been notified of an unauthorized disposition of records at the Department of the Army. We have received an allegation that the U.S. Army Corp of Engineers (USACE) has failed to notify the National Archives of its inability to locate Permit #81-079, pertaining to a levee project in Henrico County, in the Commonwealth of Virginia.

NARA requests that the Army investigate this matter to determine if the records are missing. Please note that per 36 CFR 1230.14, if records have been destroyed without NARA's proper authorization, the agency must report these incidents promptly to NARA.

In accordance with 36 CFR 1230.16, NARA also requests that your agency provide NARA with a response within 30 days that includes a description of the records; the records schedule disposition citation that covers the files; details regarding the records destruction incident and recovery efforts; and a statement of the safeguards that have been or will be implemented to prevent future unauthorized disposals of such records. The National Archives and Records Administration (NARA) has received the Department of the Army's response regarding NARA's request for further information pertaining to an allegation of the U.S Army Corp of Engineers' (USACE) failure to report the loss of Permit #81-0479 that relates to a levee project in Henrico County, Virginia. During your investigation, the Army determined that USACE possesses Record of Permit books that contain information of past permits issued, including details relating to Permit #81-0479; and that the actual permit was destroyed in accordance with NARA schedule authority, NC1-AU-80-16.
